The faculty members of the Program are an essential component of the Program. Each faculty member must perform the assigned responsibilities to assure that the quality of the Program remains high.

Faculty recruitment and employment practices for the Program will be non-discriminatory with respect to any legally protected status, such as race, color, religion, gender, age, disability, national origin or any other protected class.

The Program historically recruits volunteer adjunct faculty members from within the Imaging Services Department of the sponsoring institution or from one of the Clinical Education Settings. The Program posts a vacancy or opening for an instructor (clinical or didactic) via e-mail and communication through the clinical management software. An individual interested in the position informs the Program Director. The Program Director will provide a copy of the qualification requirements, expectations and application form to the applicant. The Educational Advisory Committee will review the application form to determine if an applicant meets the needs of the Program. If there are no qualified applicants, the Program will consider advertising for the position. A copy of the application is located in Program Procedures.

Recruitment of a full-time faculty or Program official will follow the sponsoring organization's recruitment standards.

Program Director qualifications are:

- Minimum of a master's degree
- Proficient in curriculum design, evaluation, instruction, program administration and academic advising
- Documents three years of clinical experience in radiography
- Documents two years' experience as an instructor in a JRCERT-accredited program
- Hold current American Registry of Radiologic Technologists (ARRT) certification and registration
- Hold current Nebraska Medical Radiographer License

Clinical Coordinator qualifications are:

- Minimum of a bachelor's degree
- Proficient in curriculum development, supervision, instruction, evaluation and academic advising
- Document two year's clinical experience in radiography
- Document one year's experience as an instructor in a JRCERT-accredited

program

- Hold current American Registry of Radiologic Technologists (ARRT) certification and registration
- Hold current Nebraska Medical Radiographer License

Full time didactic instructor qualifications are:

- Minimum of a bachelor's degree
- Document two years' clinical experience in radiology
- Hold current American Registry of Radiologic Technologists (ARRT) certification and registration
- Hold current Nebraska Medical Radiographer License

Adjunct Faculty qualification are:

- Academic or professional credentials appropriate to the subject content area

Clinical preceptor qualifications are:

- Document two years' clinical experience in radiography
- Proficient in supervision, instruction, and evaluation
- Hold current American Registry of Radiologic Technologists (ARRT) certification and registration
- Hold current State Radiographer License for the State where employed

The Program shall file an instructor's qualification form (furnished by the Department of Education,) with the State of Nebraska Department of Education Private Postsecondary Career Schools, no later than thirty (30) days following assignment.

Faculty members have specific responsibilities as identified in the position descriptions. A faculty member failing to accomplish the position responsibilities may be subject to discipline by the Program Director, Immediate Supervisor, Imaging Service Department Director or the Educational Advisory Committee.
